

Limited Lifetime Warranty



Limited Lifetime Warranty on Mongoose[®] Ridge Vent

Limited Lifetime Warranty. Mongoose[®] Products Inc. ("Company") issues this warranty to the original owner of the property on which the product is initially installed. Company warrants that if Mongoose[®] Ridge Vent exhibits a defect in materials or workmanship that adversely affects its performance, Company will provide you with the exclusive remedy set forth below for a lifetime.

This Warranty is NOT transferable. The warranty period starts at the date of purchase of Mongoose[®] Ridge Vent and lasts for a lifetime or, if earlier, upon the sale of the property or removal of the ridge vent.

Exclusive Remedy. For any Mongoose[®] Ridge Vent which does not perform as stated above, Company, at its sole option and as its only obligation to you, will either (1) provide you with replacement ridge vent material; (2) repair the affected ridge vent; or (3) refund the full original purchase price (excluding labor) of the ridge vent.

Decisions as to the extent of the non-conforming ridge vent will be made solely by Company. Any replacement ridge vent, as well as any remaining original ridge vent, will be warranted only for the remainder of the original warranty period.

- (1) Damages to your Mongoose[®] Ridge Vent resulting from anything other than an inherent manufacturing defect in your ridge vent, including but not limited to:
- (a) improper fastening of your Mongoose[®] Ridge Vent, faulty installation, or installation not in strict accordance with Company's installation instructions, including, but not limited to, particularly those instructions regarding the proper placement and interlayment of felts with cedar shakes.
 - (b) application of cleaning solutions, paint, or coatings.
 - (c) settlement or movement of the building walls, foundation, or roof deck.
 - (d) defects in, or failure or misapplication of, materials (i) used either as a roof base over which Mongoose[®] Ridge Vent was applied, or (ii) as the roof cap applied over Mongoose[®] Ridge Vent.
- (2) Damage to your ridge vent resulting from causes beyond normal wear and tear, including, but not limited to:
- (a) acts of God, such as hailstorms, lightning or wind.
 - (b) impact of foreign objects or traffic on the roof.
 - (c) improper storage or handling of the ridge vent.
- (3) CONSEQUENTIAL OR SPECIAL DAMAGES of any kind whatsoever, including DAMAGE TO THE INTERIOR OR EXTERIOR OF ANY BUILDING or to any property contained in or near it and also including damage resulting from business interruption.

- (4) Damages resulting from the removal and reinstallation of your Mongoose[®] Ridge Vent.
- (5) Labor costs incurred in connection with the removal or replacement of your ridge vent or related work.

Notification of Claims. To file a claim under this Warranty, you must send a notice in writing, together with proof of purchase to establish that you are the original owner and proof of installation date, to: Mongoose[®] Products Inc., 115 Lismore Ave., Glenside, PA 19038, within thirty (30) days after discovery of the alleged defect.

Note: Notice to your contractor or dealer is NOT notice to COMPANY. Within a reasonable time after proper notification, Company will evaluate your claim and resolve it in accordance with the terms of this Warranty. Company may require you to submit, at your own expense, a sample for testing and/or photographs. You should have this warranty certificate signed and dated by your contractor or dealer to help establish proof of purchase and related information. You should retain this certificate for your records in the event you need to file a claim.

Sole and Exclusive Warranty. THIS WARRANTY IS EXCLUSIVE AND REPLACES AND SUPERCEDES ANY AND ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. This written warranty is your exclusive warranty from Company and REPRESENTS THE SOLE REMEDY AVAILABLE to any owner of Mongoose[®] Ridge Vent. Company makes no other representations or warranty of any kind other than that stated herein. COMPANY WILL NOT BE LIABLE IN ANY EVENT FOR CONSEQUENTIAL DAMAGES of any kind whether from breach of this warranty, negligence, strict liability in tort, or for any other cause.

Some states do not allow the disclaimer of implied warranties or the exclusion of incidental or consequential damages so the above exclusions or limitations may not apply to the disclaimer of implied warranties or you.

Modification of Warranty. This Limited Lifetime Warranty may not be changed or modified. No one, including any representative or employee of Company, has authority to assume any additional liability or responsibility for Company in connection with your Mongoose[®] Ridge Vent except as described in this Warranty. The Warranty gives you specific legal rights, and you may have other rights which vary from state to state.

Effective Date. This Limited Lifetime Warranty is effective for Mongoose[®] Ridge Vent — sold after August 31, 2011.
